

Talent Clearance Release (“Release”)

I, the undersigned, in exchange for the possibility of being featured in the Productions(s) (as defined below), hereby grant to Colorado Parks & Recreation Association and Kansas Recreation and Park Association, their affiliates, directors, officers, members, managers, employees, licensees, agents, representatives, subsidiaries, successors and assigns, or any of them (each individually, and collectively, “CPRA” and "KRPA") a non-exclusive, worldwide, irrevocable, perpetual, transferable, right and license, to use of my name, face, likeness, voice, appearance, statements or comments, actions, and all instrumental, musical, and other sound effects produced by me, under my name as undersigned, or under any other name (collectively, “My Likeness”) on, in, and/or otherwise in connection with (a) the production(s) listed below (“Production(s)”), (b) any distribution, exhibition, advertising, and other exploitation of the Production(s) and (c) any derivative work created by CPRA/KRPA or any licensee utilizing My Likeness whether or not as part of the Production(s). I irrevocably assign to CPRA/KRPA (a) any and all copyright I may have in and to My Likeness in the Production(s), and (b) the right to use, print, produce, publish, copy, display, perform, promote, exhibit, exploit, transmit, broadcast, disseminate, market, advertise, sell, lease, license, transfer, modify, edit and create derivative works from the Production(s) and My Likeness in any manner, media or embodiment, now known or hereafter developed or devised (collectively, “Media”) in which the same may be used or incorporated, in whole or in part, for any purpose, in all languages and throughout the world, in CPRA’s sole discretion. I HEREBY WAIVE ANY RIGHT THAT I MAY HAVE TO INSPECT OR APPROVE OF USE OF MY LIKENESS IN THE PRODUCTION(S) OR AS OTHERWISE PERMITTED HEREBY.

In executing this Release, I understand CPRA and/or KRPA is relying on the rights granted to it herein and that it may incur substantial expense as a result. I hereby represent and warrant to CPRA: (a) I have not been induced to execute this Release by KRPA and/or CPRA’s representatives or any other person and I do so of my own free will after adequate time and opportunity to consult with a legal advisor of my choosing; (b) I understand that CPRA is under no obligation to exercise any rights, licenses, and privileges herein granted or to use My Likeness in any Production or otherwise; (c) I have read and understand the terms and conditions of this Release; (d) I have reached the age of majority and have the right to contract in my own name, or, if applicable, I am fully authorized to sign as an agent or guardian on behalf of any person under the age of eighteen (18) or corporation or other entity on whose behalf I am signing ; (e) I am not currently under the influence of any alcohol, drugs, or medication that may impair my ability to provide my assent to this Release; (f) I understand this contract is not cancelable by me; (g) I have not granted any person or entity any rights in or to My Likeness in conflict with the terms hereof; (h) use of My Likeness by KRPA and/or CPRA shall not infringe any third party rights nor cause damage or violate any right of privacy of any third party; and (g) this Release is binding on my heirs and assigns.

I hereby irrevocably release and discharge and agree to and hold harmless CPRA and/or KRPA from and against any and any and all losses, damages, claims, demands, causes of action, judgments, and expenses (including court costs and attorneys’ fees), and other liabilities arising out of or resulting from my participation in the Production(s) or use of My Likeness, including without limitation, personal injury, claims of libel, slander, invasion of privacy, right of publicity, defamation, trademark, and copyright infringement.

I UNDERSTAND AND AGREE THAT, APART FROM THE POSSIBILITY OF BEING FEATURED IN THE PRODUCTIONS, I WILL NOT RECEIVE ANY OTHER CONSIDERATION OR BE COMPENSATED, NOW OR AT ANY FUTURE TIME, FOR ANY USE OF MY LIKENESS IN ANY PRODUCTION(S) HEREUNDER.

This Release contains the entire agreement between the undersigned and CPRA/KRPA with respect to the subject matter hereof and supersedes all previous agreements, whether oral or written between the undersigned and CPRA/KRPA. This Release shall be governed and construed in accordance with the laws of the State of Colorado and the State of Kansas. This Release and the rights and obligations provided for hereunder shall be binding on and shall inure to the benefit of the parties, and their heirs, legal representatives, administrators, licensees, successors, and assigns.
